Applicants must be able to answer yes to all questions to be considered qualified. Any Applicant who answers no to any of the questions will automatically be disqualified. Additionally, any information requested below must be attached to this application. Verification of the accuracy of responses may occur at any time. Applications must also submit a Summary of Services. Using no more than two pages, the Applicant will provide a statement of their qualifications and describe their program framework. Specifically, the Applicant will describe the services they will provide to Court Users, and their qualifications to provide the services. Application status will be provided to applicants by the chosen vendor from page 2.
